Her research focuses on cross-national and interdisciplinary explanations of philanthropy and is funded by a veni grant from the Netherlands Scientific Organization (starting May 2010). Together with other sociologists she has published on philanthropic behavior in – among others- *Social Forces*, *Voluntas* and *the Nonprofit & Voluntary Sector Quarterly*.
